St. Mark's Cathedral ("St. Mark's", "we", or "us") is committed to respecting your privacy and the security of your personal information. We are committed to being transparent about the data we collect about you, how it is used, and with whom it is shared. The purpose of this Privacy Policy is to provide a clear understanding of the types of Personal Information we collect, how we may use that information, and with whom we may share it.

"Personal Information" or "Personally Identifiable Information" refers to the information or data about you or that can be used to identify you (e.g., name(s); address(es), telephone number(s), email address(es) or other information or data).

St. Mark's owns and operates the https://stmarkscathedral.net/ website (the "Website"), which provides the "Service." As a user of our Services, you agree to the collection, use, and sharing of your personal data subject to this Privacy Policy.

Collection of Personal Information

Personal Information You Provide

For a better experience while using our Service, we may ask you to provide us with certain personally identifiable information through a web form, during registration, while setting up an account, or when you contact us, including but not limited to your name, phone number(s), email address(es), and mailing address(es). The information that we collect will be used to contact or identify you. Donor Information Collection and Use

In addition, whenever you make a gift using the Service, Personal Information and other data may be requested on a form. The information requested includes name, address, and payment or financial information, such as credit card number and expiration date. This information is used to obtain payment from the appropriate clearinghouse. The details of your gift, including your name and mailing address, will be entered into our donor database.

Other Site Features

From time to time, we may change our Website to offer various features, we may ask you to submit certain personal information so we can provide you with and communicate with you about these features.

Personal Information Collected by Automated Means

We want to inform you that whenever you visit our Website, we automatically collect information sent to us by your browser called "Log Data". Cookies

Our Website uses these "cookies" to collect information and improve our Website. You have the option to either accept or refuse these cookies, and know when a cookie is being sent to your computer. Most web browsers recommend and automatically allow sites to save and read cookie data. But if you prefer, you can edit your browser's settings to disable or block cookies in the future. Please note, if you choose to disable or modify your cookies settings, you may not be able to access certain features, content, or services.

Web Beacons

Web beacons are used to recognize certain categories of information about visitors, such as locations and time and date a page is viewed. The data collected by web beacons contain no personally identifiable information and is only used for analytics and performance purposes.

IP Addresses

An IP address is a unique identifier that certain electronic devices use to identify and communicate with each other on the Internet. When you visit our Website, we may view the IP address of the device you use to connect to the internet. We use this information to determine the general physical location of the device and understand from what geographic regions our Website visitors come. We also may use this information to enhance our Website.

Children's Privacy

Our Services are only intended for adults and are not directed to children under the age of 13. We do not knowingly collect personal identifiable information from children under 13. In the case we discover that a child under 13 has provided us with personal information, we immediately delete this from our servers. If you are a parent or guardian and you are aware that your child has provided us with personal information, please contact us so that we will be able to take the necessary actions.

Use of Personal Information

We may use the personally identifiable information you provide on the Website for our internal purposes. These purposes include administration of the Website, market research, data analytics, and compliance with our legal obligations, policies, and procedures.

Retention and Disposal of Your Personal Information:

St. Mark's will keep your personal information until such a time that we no longer expect to need to use it for any legal and legitimate purpose and otherwise in accordance with all applicable laws. At the appropriate time, we will take reasonable steps to dispose of your personal information or ensure that your personal information is de-identified, except where we need to retain such information to satisfy legal and professional ethical obligations.

Disclosure of Personal Information

Information We Share

St. Mark's will not rent, trade, sell, or disclose personally identifiable information about you to unaffiliated third parties except in accordance with this Privacy Policy. We may share your information under the following circumstances:

We may share the information we collect with other parties, including the following:

- With third-party companies and individuals to assist us with providing and marketing our services, to perform Service-related services, or to assist us in analyzing how our service is used. This may include, but is not limited to, payment processors, data hosting services, analytics services, online store support, advertising partners, and email service providers.
- With Constant Contact, to send email marketing and text message communications. As Required by Law

We may disclose information about you if: (i) required to do so by law or pursuant to legal process, (ii) in response to a request from law enforcement authorities or other government officials, or (iii) when we believe disclosure is necessary or appropriate to prevent physical harm or financial loss or in connection with an investigation of suspected or illegal activity.

Digital Advertising & Analytics

We may authorize our advertising partners to use cookies and similar technologies on our Website to automatically collect certain information from your device, and we may share information about you and your interactions with our Website with our advertising partners. These partners may also collect information from other websites or apps over time, including information about relationships among different browsers and devices.
